## Before your treatment

- Do not sunbathe actively and / or use a solarium for 2 weeks prior to treatment. If you cannot avoid the sun, we recommend that you use an anti-sunscreen with an SPF of at least 30. When you are outside for a longer period of time, we recommend that you apply the sunscreen every 2 hours.
- Do not use self-tanning cream on the treatment area 2 weeks before the treatment.
- On the day of treatment, there should be no foundation or pigment containing powder on the skin.
- Discuss the treatment goal and the degree of skin reaction after treatment.
- It is important that you have truthfully informed the skin therapist about your health, use of medication, allergies and / or pregnancy. If there is a change in the above situations, we ask you to report this to us in time because of the possible influence on the treatment.
- **NOTE:** if you have an active cold sore, do NOT treat the face until 2 weeks after full recovery due to spreading virus.
- Prior to the treatment, it is recommended to start the intake of arnica granules 5 days earlier and up to 5 days after the treatment. This will reduce bruising, which may or may not occur in the treatment area.

## During your treatment

- During the first treatment, the treatment area is determined, and the intensity chosen together with you depending on your treatment indication. This may concern the following indications; skin rejuvenation, improvement of wrinkles, improvement of skin texture, reductive of skin discolorations, reduction of acne, reduction of (acne) scars or a combination of these.
- Please note that the treatment can be sensitive. You can also feel heat in the skin. This provides collagen stimulation and thus improvement of the skin.
- The skin is treated with a micro-fractional radio frequency and can thus "open" the skin, so that blood points can be visible to a greater or lesser extent. This depends on the settings and the desired result.



## After your treatment

- Please note that the skin may be red / purple / blue for up to 10 days after the treatment and swelling may be visible. Sometimes sebaceous glands are temporarily activated.
- In some cases, there will be some irritation / pimples in the days after the treatment.
- The skin will heal quickly, but this will cause (miniscule) crusting for up to a week afterwards.
- Do not sunbathe actively and / or in a solarium until 4 weeks after the treatment. If you cannot avoid the sun, we recommend that you use an anti-sunscreen with an SPF of at least 30. When you are outside for a longer period of time, we recommend that you apply the sunscreen every 2 hours.
- Heliocare and Mesoestetic sun protection products protect you against all forms of radiation, including UVA, UVB, HEV and IR light. These products are available in practice.
- You may not close the skin on the day of the treatment, with the exception of the cream that the skin therapist may recommend.
- Swimming, sauna, massages or other treatments elsewhere are not recommended for 2 days. Consult your skin therapist for more information.
- If you do not trust the skin reaction, we advise you to contact the Basic Skincare skin therapist.
